Meaningful participation can have a positive influence on the well-being of children and young people and ensures that policy is better suited to their environment and needs. More and more municipalities therefore want to use youth participation for the development, implementation and evaluation of policy. In practice, however, this is only used to a limited extent, despite the many tools and approaches that have now been developed. How come?
- Data Description  
This report provides insight into individual and contextual factors associated with the use of youth and youth participation (4 to 26 years) in the policy of the municipality of Rotterdam.
- Method  
We investigated the factors associated with involving youth (aged 4 to 26 years) in the development, implementation, and evaluation of youth policy. A total of nineteen civil servants from the municipality of Rotterdam participated in in-depth interviews.
- Results  
The research shows that not one factor is decisive, but that various factors interact. Many policy advisors lack a top-down vision, which makes them doubt whether participation is really the intention. Experiencing a lack of support and views about children and young people encourages cold feet. There are also unwritten rules that make policy advisors extra careful.
- Conclusion  
To improve the use of youth and young people's participation in policy, a coherent approach is needed that intervenes on a combination of factors.
